## II. The powers and duties of officers and employees

### Commissioner of Police

(a) In exercise of the powers conferred by section 6 of the Calcutta Police Act, 1866 (Bengal Act IV of 1866), and by section 18 of the Code of Criminal Procedure, 1898 (Act V of 1898), the State Government appoints the Commissioner to be a Presidency Magistrate in Calcutta and empowers him to sit singly as a Presidency Magistrate.

(b) The State Government vests the Commissioner with the powers of a Magistrate of the First Class to be exercised within the limits of the suburbs of Calcutta. The said powers shall be exercised by him for preserving the peace, preventing and detecting crime, apprehending and detaining offenders in order to their being brought before a Magistrate and for the performance of any other duties imposed upon him by any law for the time being in force.

(c) In exercise of the powers conferred by sub-section (1) of section 144 of the Code of Criminal Procedure, 1898 (Act V of 1898), the State Government vests the Commissioner with the power to issue orders under section 144 of the Criminal Procedure Code in the town and the suburbs of Calcutta.

(d) The Police force shall be under the exclusive direction and control of the Commissioner who may from time to time, subject to the control of the State Government frame such orders and regulations as he shall deem expedient relative to the general government of the force, the places of residence, the classification, rank, distribution and particular service of the several members thereof, their inspection, the description of arms, accoutrements and other necessaries to be furnished to them, and all such other orders and regulations relative to the said Police Force as the said Commissioner shall from time to time deem expedient for preventing neglect or abuse, and for rendering such force efficient in the discharge of all its duties.

(e) The Commissioner may at any time suspend or dismiss or inflict any other punishment on any member of the subordinate ranks of the Police force whom he shall think remiss or negligent in the discharge of his duty or otherwise unfit for the same.

### Additional Commissioners and Joint Commissioners of Police

They perform, exercise and discharge such of the duties, powers and functions of the Commissioner of Police as are assigned or delegated under his orders. They look after the functioning of the units under their supervision in close touch with the Deputy Commissioners of Police of the respective units. They are responsible for guiding and directing such Deputy Commissioners of Police in their work.

### Deputy Commissioner of Police

He is responsible for the general supervision of the division/unit under him. He should ensure by constant supervision that the prevention, investigation and detection of crime in his jurisdiction are properly and efficiently dealt with by the police stations under his command. He should enforce discipline and redress grievances.

## Assistant Commissioner of Police

An Assistant Commissioner is, subject to the control of the Deputy Commissioner, responsible for the supervision, control and general efficiency of the work and functions, both executive and administrative, entrusted to his charge. He is responsible for all matters relating to the discipline and efficiency of the force directly under him and is expected to be in close touch with the condition of work within his charge and be accessible to the members of the public at all times. The Deputy Commissioner shall define clearly in a divisional or departmental order duly approved by the Commissioner the duties which the Assistant Commissioners shall perform and the sphere of action, if any, allotted to them.

### III. The procedure followed in decision making process including channels of supervision and accountability

The Commissioner of Police, assisted by Additional Commissioners, is the head of organization.

Additional Commissioners, Special Additional Commissioner & Joint Commissioners of Police and Joint Commissioner, being assigned supervision of different units by the Commissioner, use to keep close watch and supervision over the units including administrative works assigned at headquarters.

Deputy Commissioners are in-charge of different units and also act as Drawing & Disbursing Officer of respective units. They are the Disciplinary Authority of the units they command.

Assistant Commissioners, under direct control, supervision and guidance of the respective Deputy Commissioners, oversee the functioning of the Police Stations/ Sections under their charge and advise/guide the Officer-In-Charge of such Police Stations/Sections for smooth running of the administration.

### IV. The norms set for the discharge of functions:

- 1) Officers-in-Charge of Police Stations must ensure good behaviour by all officers and men towards the complainants/informants etc. in the Police Stations.
- 2) Divisional Deputy Commissioners must visit Police Stations at least once every fortnight so that public-grievances can be heard directly. Joint Commissioners shall make such visits once a month in their respective areas. Such programme may be made well in advance so that it can be given on Kolkata Police Website and displayed in the Police Station Notice Boards.
- 3) Officers-in-Charge of Police Stations should keep Control Room informed of all important incidents, which in turn, would inform concerned superior officers.
- 4) Officers-in-Charge of Police Stations, Divisional Assistant Commissioners and Divisional Deputy Commissioners should feel free to contact the Commissioner or other superior officers, whenever necessary.
- 5) All reports/returns of Deputy Commissioners should be submitted through the concerned Joint Commissioner who may forward the same to Commissioner.



- 6) All reports called by the Commissioner from the Deputy Commissioners should be forwarded through the Joint Commissioner and the Additional Commissioner who should give their specific comment and forward the same to the Commissioner.
- 7) All proposals, including administrative proposals, should be routed through the normal chain of command.
- 8) Divisional Deputy Commissioners and Divisional Assistant Commissioners should inspect each Police Station under their charge at least once in a calendar year and forward the copy of inspection report to the concerned Joint Commissioner who should keep the Commissioner and the concerned Additional Commissioner informed of the salient points of the inspection remarks.
- 9) Joint Commissioners should inspect at least four Police Stations in a calendar year and Additional Commissioners should inspect at least two Police Stations in a calendar year.
- 10) Deputy Commissioners must inspect their own offices at least once in a calendar year.
- 11) Concerned Joint Commissioner and Additional Commissioner should inspect Battalions and other units in such a way that each unit is at least inspected once in a calendar year.
- 12) Leave application of Inspectors and above should be routed through the normal chain of command i.e. through concerned Deputy Commissioners, Joint Commissioners and Additional Commissioners.
- 13) Divisional Deputy Commissioners should formulate a chart of night patrol by the officers of his division every month and the summary of night patrol should be reflected in monthly force return.

The Commissioner of Police and the staff working under him are bound by the rules, regulations, orders and circulars issued time to time by the Govt. of West Bengal. Besides this, the administration of Kolkata Police is guided by the Police Regulations Calcutta, 1968, the Calcutta Police Act, 1866, the Calcutta Suburban Police Act, 1866, the West Bengal Service Rules, All India Service Rules etc.

VII. Particulars of arrangement that exists for consultation with or representation by the members of the public in relation to the formulation of policy or implementation thereof .

Kolkata Police has the objective of providing safety and security for the citizens and Kolkata Police always welcome and encourage the feedback from citizens. Kolkata Police through its various community policing schemes has been constantly striving to improve its relation with the citizens of Kolkata and ensure highest level of public safety and welfare for them. Kolkata Police is conscious that with citizen's support it can be more successful in its endeavour to serve the community.

The members of the public can give their suggestion or Feedback by visiting the official website of Kolkata Police i.e. [www.kolkatapolice.gov.in](http://www.kolkatapolice.gov.in) and clicking on either "Write to Commissioner of Police" or "Feedback". The members of the public can also get involved with Kolkata Police by visiting the website and giving information about the most wanted persons, missing persons, report of a crime, missing vehicles and traced vehicles.

The implementation of any policy would be carried out strictly in accordance with the provisions therein. Public would be informed about the policy and discussion would be carried out with the members of the public during interactive session and occasional meetings. The members of public can meet the senior officers with suggestion either during their visit to Police Stations or can send such suggestion directly which are taken care of after due consideration. For this purpose, Deputy Commissioners have started visiting each Police Station twice in a month and Spl. Addl. Commissioner of Police & Joint Commissioners once in a month under advance intimation through Kolkata Police Website and Police Station Notice Board.
