- 7. The work will be taken up within 07 (seven) days after receipt of work order, failing to which legal action may be taken against the firm.

## PERCENTAGE RATE TENDER AND CONTRACT FOR WORKS GENERAL RULES AND DIRECTIONS FOR THE GUIDANCE OF CONTRACTORS

- 1. All works proposed for execution by contract will be notified in a form of invitation of tender posted in public places and signed by The Deputy Commissioner of Police, 2ndBn. K.A.P. This form will state the work to be carried out, as well as the date of submitting and opening of tenders and the time allowed for carrying out the work, drawings and any other documents required in connection with the work signed for the purpose of identification by The Deputy Commissioner of Police, 2ndBn.,K.A.P., 29/1 B T Road, Kol-02, shall also be open for inspection by the contractor at the office of The Deputy Commissioner of Police, 2ndBn.,K.A.P., 29/1 B T Road, Kol-02, during office hours.
- 2. In the event of the tender being submitted a firm, it must be signed separately by each member thereof or in the event of the absence of any partner, it must be signed on his behalf by a person holding a power of attorney authorizing him to do so. Such power of attorney to be produced with the tender and same in the case of a firm carried on by one member of a joint family, it must be disclose that the firm is duly registered under the Indian Partnership act.
- 3. Receipts for payments made on account of a work, when executed by a firm, must also be signed by the several partners except where the contractors are described in their tender as a firm in which case the receipts must be signed in the name of the firm by one of the partners or by other persons having authority to give effectual receipts for the firm.
- 4. Any person who submits a tender shall fill up the usual printed form, stating at what rate he is willing to undertake each item of the work. Tenders which propose any alteration, in the work specified in the said form of invitation of tenders or in the time allowed for carrying out the work, or which contain any other conditions of any sort, will be liable to rejection. No single tender shall include more than one work but contractors who wish to tender for two or more works shall submit a separate tender for each. Tenders shall have the name and number of the work to which they refer written outside the envelop.
- 5. The tender committee will open tenders in the presence of any intending contractors who may present at the time and will enter the amounts of the several tenders in a comparative statements in a suitable form.
- The accepting authority reserves the right to reject any or all the tenders without assigning any reasons and he will not be bound to accept either the lowest tender or any of the tenders.
